

## Bill C-7 and Medical Assistance in Dying (MAiD)

Dear Parishioners:

Recently Cardinal Thomas Collins, Archbishop of Toronto, released a letter expressing his concerns with the re-introduction of the Bill C-7. The legislation would expand the eligibility criteria for euthanasia. Here are some of the highlights from Cardinal Collins' statement:

• When the law came into effect in 2016, the opponents of MAiD felt that it would be a matter of time before the criteria would be expanded. The government insisted that safeguards would be implemented to protect the vulnerable. Now less than four years after

the law came into effect, we already see the expansion of euthanasia.

- Under the current bill, euthanasia would be offered not only to the terminally ill but to those who are suffering from an incurable disease or disability. We know that people can live with such illnesses for many years. Out of convenience to the state, we would allow for the death of these individuals.
- In 2016 the government assured Canadians that there would be a thorough review of MAiD for at least 5 years before new legislation is introduced. Yet the government is hastily moving forward with the expansion of euthanasia without any critical review.
- Only 30% of Canadians have access to quality palliative care. Pain and loneliness are the biggest motivators when it comes to euthanasia. Palliative care can address those issues.
- Under the proposed legislation, disabled Canadians with no terminal illness will now be eligible for lethal injections. The lives of disabled Canadians matter. They should never be seen as a burden to our society. Now they can be pressured from family, friends and from medical care personnel to end their lives prematurely.
- All Canadians should be concerned about the legislation and contact their Member of Parliament. Let us take the time to be truly present to those who may feel they are on the margins in our community. Human dignity must be recognized in everyone, especially the dying and the disabled.
- We must try to foster a culture of care and love for one another. The answer is not assisted death in its many forms. It is to be found in accompanying our family, our friends and even strangers to assist them in life, recognizing the inherent dignity of every person.

Aside from prayers, let us do what we can to let our Members of Parliament know that we stand for the culture of life and not the culture of death.
